Course Format

This is a 16-week in-person course. Our focus will be macroeconomic concepts and applying these concepts to practical, real-life situations by analyzing them through economic frameworks both in discussion and in writing. Each class will begin with a topical discussion to illustrate the classroom concepts. After every class, you will be assigned a short quiz and the preparatory material for the next class. The midterm will be a written Article Analysis and the final will be a Comprehensive Exam. Assigned work will primarily be aimed at assessing your understanding through the **application** of our economic lessons.
